

## The Local Historic District Corner

ur city-sponsored meeting designed to encourage input into our Design Standards took place as scheduled on July 8. Approximately a dozen people attended, including myself, HPNA President David Conner, and Terri Myers of Preservation Central. Susan Kirby, of the Historic Preservation Office, with the help of Jerry Rusthoven and Steve Sadowsky, conducted the meeting. Many of the neighbors attending brought questions about the meaning of specific provisions in the Design Standards; others brought general concerns about Local Historic Districts.

We became aware of the need to clarify certain issues in the Design Standards and reconsider others. In addition, city staff told us that we need to make some changes in wording to make the Design Standards legally airtight. We hoped to have a follow up meeting with city staff to clarify required changes, but as of this writing, that meeting has not taken place. Given the time spent on drafting our Design Standards, we do not take changes lightly. Only with a clearly defined mandate from the city will we make them.

By the time you read this column, we will also have appeared before the



# HPNA General Meeting Minutes July 12, 2010, 7 p.m.

**1.Tire Slashing Update: John Lipscombe**, Assistant County Attorney, on Prosecution

John Lipscombe tried cases in the Criminal Division for 19 years before moving to Administration last year. His office has walk-in service where they will discuss your concern with you and determine if it should be taken to the police. He can also check to see where particular individuals are in the system if called. His cell is 826-5517. Police also call his office at all times day and night with questions.

The conversation quickly moved toward the local tire slashings and included the following:

• If you do have a punctured tire, take pictures. When the tire is replaced, have the shop cut out the puncture area. Tag the back of the photos with your contact information, what happened, when, which tire on car. location when discovered, etc. Call 974-5000 and ask for Sgt. Robert McGowan to report the incident and ask that an officer come by to pick up the evidence and place it in the case file. (An instrument was confiscated last week which can be compared to the puncture.) Doing this can help build circumstantial evidence and it can be presented as evidence in court.

• If a property owner tells police he does not want a particular person on his property any more, police will then have the owner sign a document and will officially issue a criminal trespass warning to the person. This will allow them to pick up the person at a later date should he again trespass.

•Mr. Lipscombe suggested that the neighborhood begin a neighborhood patrol, which is something Austin Police Department (APD) can help HPNA develop.

• Most important is to report every incident to APD. If you see something suspicious, it is a good idea to take a picture and make note of as much information as you can about where and when. Then report it. Nothing is official unless it is actually reported separately each time.

• Regarding the suspected slasher Tommy Kelly: He actually likes to go to trial, and attempts to play on the sympathy of the jury, which has worked for him in the past. He has also accused the police of police harassment. He and a friend have both been caught slashing tires in the past.

• Should this ever go to trial and you have provided evidence, you will be asked to be a witness stating what you saw regarding your slashed tire. The Prosecutor's office will talk to you before the trial.



#### 2. Update on Hyde Park Local Historic District

There was a city-sponsored meeting last week where people from Hyde Park came to offer their input and ask questions about the Design Standards. The meeting was run by the Historic Preservation staff. The next step is for the Preservation Office and City Attorney to review the wording to make sure it is legally defensible. They will then meet with members of HPNA to review the changes they suggest. The final document will note any areas where the City and Hyde Park do not agree.

Late this month, that version will go before the Historic Landmark Commission for discussion. This schedule could be pushed back, depending on staff availability to work on the document before then.

A poll has been taken regarding a possible Caswell/Ridgetop Local Historic District and someone has come forward to help lead this effort. More meetings are planned.

## 4. Possible new use of Triangle property at 45th and Guadalupe

HPNA is leaning toward supporting a proposed use at this location. No action will be taken unless and until the property is sold.

#### 5. Review of Homes Tour

The actual numbers are still out, but we did make a profit. David Conner has agreed to chair the Tour next year.



#### EXPERT HARDWOOD FLOOR REFINISHING



Mosquitoes have become a problem with the heavy rains we've been having lately. You can follow these tips to help deal with mosquitoes.

• Drain all standing water. Check low lying areas in the yard, dishes under flower pots, pet bowls, buckets, tree holes, wheel barrows or garden carts, etc.

• For water that cannot be drained (pet water bowls, bird baths, rain water collection barrels) you can use Bacillus thuringiensis var. israelensis (commonly know as mosquito dunks).

• Avoid being outside during peak mosquito activity times of dusk and dawn.

• Prune areas with thick vegetation to reduce hiding areas for the mosquitoes. These areas could also be treated with a pesticide.


• Make sure window and door screens are in good repair.


• Use fans to keep air moving.

• Use repellent with active ingredients such as DEET, picaridin or oil or lemon eucalyptus.

• Make sure pets are protected against heartworms which are transmitted by mosquitoes.
